2020-2021 Tuition Schedule

Purple Circle is a full year, five day a week program. We are open from September through mid-August. The prices below reflect the full-year cost, including summer.

Purple Circle offers two different payment plan options for families.

Following an initial deposit* in February (current families) or March (incoming families) to secure your child’s place in the program, families have the following payment plan options:

- Option 1: Eleven (11) monthly payments beginning in April 2020
- Option 2: Nine (9) monthly payments beginning in June 2020

*Note: The Deposit is 15% of annual tuition unless Option 1 is selected, in which case the deposit is reduced to 1 month (8.3%) of annual tuition.

The applicable payments for each program schedule under each payment option are detailed below.

PAYMENT OPTION 1:

February/March 2020 Deposit (8.3% = 1 month tuition) followed by 11 equal payments through February 2021

Contracts for Current Families continuing enrollment for 2020/2021 will be distributed on February 3rd with a due date for signed contracts and deposits on February 14th.

Contracts for New Families for the 2020/2021 school year will be sent on February 27th with an official acceptance to Purple Circle Early Childhood Program. Signed Contracts, Registration Forms and Tuition Deposits are due no later than noon on March 5th.

Families who apply and accept enrollment after March 5th, 2020 will have a revised payment schedule.

Each family must indicate their preferred choice of Payment Options by initialing their selection on Page 2 of their Contract and submitting the respective Deposit with both signed copies of their Contract. Thereafter, a copy of the family's Contract will be returned with a Board-approved signature, and tuition payments will be invoiced to each family based on the timeline of their preferred selection.

Important Considerations:

Upon signing the Contract for the school year term, it is the expectation of the Center that your child will attend and that tuition will be paid in full in accordance with the selected payment plan.

Purple Circle reserves the right to rescind our offer of enrollment if the required documentation and payment are not received by noon on March 5th, 2020.
