Along with the initial deposit in February and March (current families) or March (incoming families), families are required to submit a signed contract and registration form to secure their child's enrollment.

- Contracts for Current Families continuing enrollment for 2025/2026 will be distributed on February 3<sup>rd</sup> with a due date for signed contracts and ½ deposits on February 12<sup>th</sup>. The second ½ deposit is due on March 7<sup>th</sup>.
- Contracts for New Families for the 2025/2026 school year will be sent on February 27<sup>th</sup> with an official acceptance to Purple Circle Early Childhood Program. Signed Contracts, Registration Forms and Tuition Deposits are due no later than noon on March 6<sup>th</sup>.
- Families who apply and accept enrollment after March 6<sup>th</sup>, 2025 will be placed on a catch-up schedule to be discussed at time of enrollment.

A copy of the family's Contract will be returned with a Board-approved signature, and tuition payments will be invoiced to each family based on the above timeline.

#### Important Considerations:

Upon signing the Contract for the school year term, it is the expectation of the Program that your child will attend and that tuition will be paid in full in accordance with the tuition schedule.

Purple Circle reserves the right to rescind our offer of enrollment if the required documentation and payment are not received by noon on March 6<sup>th</sup>, 2025.
